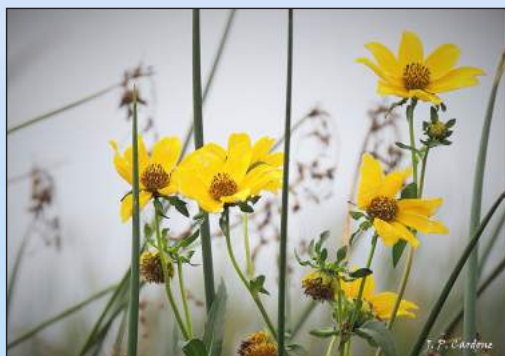

**Location:** Heckscher Park, Route 25A and Sabbath Day Path, Huntington, NY. Approximately 50 mi. east of New York City. Convenient unloading, free parking.

**Display Space:** Booths are approximately 10' wide by 10' deep. All tables, racks and chairs are the responsibility of the exhibitor. **TENTS MUST BE SECURELY ANCHORED.**

**Awards for Fine Arts and Crafts Fair:** Judging on Saturday. Ribbons will be given later that afternoon. Cash prize and ribbons will be awarded at the judge's discretion.

#### No Rain Dates

**Specifications:** Applications must be received by May 24, 2019. Applications received after the deadline will be reviewed subject to space availability. You will be informed of acceptance or rejection by May 28, 2019.

**Fees:** There are no application fees. Booth fees are non-refundable. See Cancellation Policy.

**Responsibilities of the Exhibitor:** Each exhibitor assumes his/her own risk and should carry appropriate insurance. The Art League cannot assume liability for damages, loss or theft to an individual's work or display. Each exhibitor is also responsible for collecting New York State Sales Tax. Use the following to obtain sales tax information and application: NY State Dept. of Taxation and Finance 1-800-972-1233 or [www.nystax.gov](http://www.nystax.gov). Exhibitors must not pack up before closing time on each day. Exhibitors must stay until closing time on both days.

**Eligibility:** These juried shows are open to all artists, crafts people, photographers and printmakers.

**Media:** Only original art work by the exhibiting artists will be accepted. No commercially manufactured or import items will be accepted. The committee reserves the right to remove any exhibit not conforming to regulations.

#### Application Requirements:

- Applicants must submit jpegs or photos that are representative of their actual work.
- Photo or jpegs of their booth.
- A completed application form.
- Resume.
- Check for booth fee and/or membership fee.
- SASE #10 envelope. If work is not accepted, photos and payment will be returned ONLY if a SASE envelope is enclosed.

**Policies & Procedures:** All work must be original and created by the exhibitor. Artists may only show work typified in their jpegs/photos. Jewelry may not be sold unless the artist has been accepted in this category. No objects from commercially sold kits or manufactured items. Only prints hand-produced by the artist, executed by monoprint, serigraph, lithograph and similar, properly signed and numbered, are permitted to be displayed on and in the booth. If your work does not meet stated qualifications, you will be asked to leave without refund.

#### Cancellation/Refund Policy:

- No refunds are given for Art in the Park.
- \$25 charge for each returned check.
